<u>Treasurer's Report</u>: We have a balance of \$6,157.26. We wrote 1 check for \$1,000 to the SideDoor Café as a dinner down-deposit. This large balance was a result of the annual dues that have come-in and the OUCC assistance. Next month we will have to pay for the dinner and the associated gifts, so our balance will be quickly reduced.

<u>Standards Report</u>: We have a stack of them and will bring them to the dinner, just in case anyone wants one.

<u>P & E</u>: Sam inquired about a shirt purchase. It would be nice to have before the dinner, that that would have to be a quick turnaround. Our council will try to take shirts to the rental/lumber yards locally like Copeland and ProBuild. These places help get the word out to the homeowners. An idea was brought up to purchase some of the Dig Safely/811 temporary tattoos, but the store room didn't have any. Let's think about placing another radio ad this summer.

<u>States Report:</u> The next quarterly spring meeting is in Eagle Crest on June 10th. We will discuss at the May meeting who will represent our council. This is supposed to be the meeting where the Presidents attend, from all the councils state-wide.

<u>Old Business</u>: There is still time to RSVP to Dan if you will be attending the dinner.
