The Common Ground Alliance (CGA) encourages the use of their Damage Information Reporting Tool (DIRT). You can check this out at www.cga-dirt.com. There was a lot of discussion about how to get compliance with reporting. Oregon is going to this reporting tool on a voluntary basis. The feeling in the room is that there needs to be a requirement with some teeth to make the reporting system work.

NOTE: We would like to see all who call for locates and do construction within the Tri-County area submit reports. It only takes minutes each month!!
