- 2. We also wanted to continue with Dixon Golf and offering the website.
- 3. We, as a committee, are vowing to meet once every 4-6 weeks, to make this upcoming golf scramble the best it's ever been! We are taking turns on hosting & selecting locations. Melanie, due to her upcoming birthday in early December, will be selecting the location for our next meeting, which we are targeting for Monday, December 6th at 4PM. Location TBD. Host TBD (host is who will pick up the tab, with the hope it can be expensed). Also, hoping to secure at least one Sponsor per meeting. Each committee member needs/hopes to bring on at least two sponsors
- 4. We will be focusing in on getting more Sponsors, of varying levels of donations, to help boost the appeal of the tournament and the raffle (hoping for more hole sponsors that provide adult beverages, games, etc. AND sponsors that will donate gifts for the raffle). Justin Brandon is offering up a Sponsor Letter that he will forward to us soon.
- 5. A few improvements were suggested, including a possible QR code for the instructions of the scramble (which were not made clear in this years), little scissors for the string, more games/fun at each hole, looking into buying out the course vs. paying per player (if it makes sense \$\$), a possible early registration discount, and possibly a morning "light adult beverage" option at check-in to kick up the fun atmosphere.
