
Figure 3 – Damages by Root Cause – Remaining Areas (by damages per 1,000 in bound locate ticket requests)



 - All of the above with the exception of:
 - Union they currently don't have a President, which is a requirement.
 - Wasco in process should be processing this week.
 - South Coast in process

To complete:

- There are still 4 Oregon SOS filings not yet started for which we are waiting for information from the council to complete the filing
 - North Coast no contact yet, sent a follow up on 8/31
 - Mid-Willamette last contact was 7/30, sent a follow up on 8/31
 - Klamath last contact was 6/3, sent a follow up on 8/31
 - Hood River last contact was 6/2, sent a follow up on 8/31
- There are 5 IRS applications that are not yet started, and 1 for which the status is in question
 - \circ all 4 of the above, and
 - Lane County no contact yet, sent a follow up on 8/31
