

**OUCC President's News Letter January, 2015** 

The New Year is under way and the Oregon Utilities Coordinating Council is gearing up for the coming year. We have the same funding available this year as last. The dues letters were emailed January 13, 2015. To receive \$2,000 assistance money each council must pay dues to the state council and send an updated officer list to Tobin Werner (see Tobin's contact info below). You may notice a difference in your dues this year as they have been updated. The dues are calculated as follows: \$50 minimum, \$50 for web page expenses, and \$0.09 per 100 of area population. Some councils will notice an increase and some a decrease. The difference comes from the fluctuation of population. The dues have not been updated since the late 1990's and we felt it was time to become current.

Did you know that there are several qualified people to speak at your meetings and events at your disposal? If you would like a speaker let me know and I will help you contact a person who is qualified to speak on the subject you request.

Attached to the email is a letter written by Johanna M. Riemenschneider, Assistant Attorney General, Department of Justice, State of Oregon to Kevin Hennessey, Chief, Pipeline Safety, PUC. The letter addresses the locating responsibility for sewer laterals. Several individuals have overcome problems by sharing this letter with facility owners who are reluctant to locate sewer laterals.
