# **Minutes:**

Minutes of the April, 2016 meeting were approved as submitted.

#### **Treasurer's Report:**

After 11 deposits totaling \$440, Contractor's Breakfast expenditure at Cousins (\$913) and shirts expenditure (\$684), the current balance is \$4817.60. We did receive dues from Charter and Art will be depositing that \$40 soon.

New services and upgrades.

#### Sheri Clark -- NW Natural

- ❖ Working in Hood River and some work has been permitted in The Dalles.
- Travis Davis is training a new person so hopefully there will be two crews.
- ❖ Waiting on core samples for Hwy 197.
- ❖ 2<sup>nd</sup>/Webber to Snipes is drafted. Goal is to have high pressure gas main relocated by July 1<sup>st</sup>.

## **Danny Saldivar – The Dalles Irrigation**

- ❖ Delivering water at about 70% capacity.
- ❖ Farmers are anticipating June 1<sup>st</sup> harvest for early cherry varieties
- ❖ There was previous damage on a landowner's property when an air valve broke. This was determined to be due to aging infrastructure, as it's from the early '60s. Therefore, they have a 5 year plan to replace their 157 air relief valves with stainless steel down to the main line. Critical areas are the east side of town and they plan to start work off-season from October 2016 through February 2017.

- $\diamond$  Will be working on the  $2^{nd}$  round within the urban growth boundary.

#### **Dale McCabe – City of The Dalles**

- ❖ Trevitt Street waterline work −6<sup>th</sup> Street and 9<sup>th</sup> Street. Street crew will pave this week.
- ❖ Sanitary sewer work on 8<sup>th</sup> Trevitt/Bridge will be paved.
- Thompson Street Storm Water Project is being wrapped up by Crestline. Paving to follow.
- ❖ Working on waterline on Federal between 9<sup>th</sup> and 10<sup>th</sup>.

❖ Design for 2<sup>nd</sup> sanitary, storm and water project on port. The water tie-in on River Rd. will be on WM3 property across NW Aluminum Smelter property and are negotiating with Google property→ then will bore under the railroad to be under 2<sup>nd</sup> St. up to Webber.
