- ✤ Maupin fiber project (pole replacement).

#### Danny Saldivar - The Dalles Irrigation

- ✤ Irrigation shut down on the 14<sup>th</sup> and water is draining.
- Soard member election is happening, so that's keeping them busy.
- Winter maintenance scheduled to begin Nov 1<sup>st</sup>.

#### Ed Ortega -Northern Wasco County PUD

- ✤ Fairly busy with customer services.
- Capital project transformer at 3 Mile Substation.
- Helping the City with Lone Pine project.

## Dale McCabe - City of The Dalles

- Crews are slowing down.
- Street is grading alleys and gravel streets.
- Water and Wastewater are working on a project (water service and sanitary sewer/storm sewer) off Webber and Bargeway.
- ✤ Water department has to install a fire hydrant.
- Awarded the contract for the Lone Pine Well Project.
- Still working on getting easements @ Federal in the alley between 7<sup>th</sup> and 8<sup>th.</sup>
- Catch basin cleaning.
- ✤ Trying to finalize 2<sup>nd</sup> street easements.
- Working on design for 6<sup>th</sup> and Snipes for new motel project. There will be frontage improvements on Snipes at the Astro station and the City will work on the area between KFC to

the shopping center. Dale mentioned the grassy area at the corner of Snipes as it's a Right of Way but there are some utilities in conflict that will need to be addressed.

- Looking into Jordan/14<sup>th</sup> storm drain issue.
- Sorosis and Columbia View Reservoir seismic upgrade and painting project.

Sherry asked about the WCUCC elections and Ed said we'd discuss them next meeting.
