### **Treasurer's Report:**

#### **New Business:**

Ed Ortega and Brewster Whitmire discussed promotional items for the school safety programs / 811 program. Ed recommended that they look to the promotional website for items. It was also suggested looking for bigger items for teachers to help promote the 811 program. The school safety program reaches an estimated 250 young children aged Kindergarten through the fourth grade in Wasco & Sherman Counties, as well as youths in Warm Springs, Kah-Ne-Tah and Young Life. School safety program will begin in May.
