Advertising with Big Screen Ads in The Dalles and Hood River Cinemas during the months of April, May and June 2020 has been extended due to the closure of non-essential businesses. At this time, Nathan with Big Screen Ads does not know when advertising will commence due to the social distancing guidelines set forth by Governor Kate Brown. Will continue to keep you all posted.

Erica Aitken, CPA with Wicks Emmett, LLP discussed information regarding WCUCC Chapter tax exempt status formation and compliance being a non-profit entity and filing of the IRS Form 501-C3. The Wicks Emmett firm would provide WCUCC Chapter, at no charge completing the Secretary of State Registration, completing and filing of IRS Form 501-C3 and filing with the State of Oregon for the tax-exempt status. They would also provide annual assistance in completing and filing necessary forms to the IRS and State. Fees incurred would be paid for by OUCC.

John Amery inquired who would be responsible for the WCUCC Chapter documents that are filed and who would work with Wicks Emmett, LLP annually to get documents completed and filed in a timely manner. After a discussion with the board, a motion was made and seconded to appoint the current WCUCC Secretary as the designated person responsible for reporting the information for tax exempt status to Wicks Emmet, LLP for reporting to the IRS. Motion passed.
