MEETING MINUTES April 19, 2022 8:03 a.m.

John Amery called the meeting to order at 8:03 a.m. via Zoom/Teleconference.

Minutes:

A motion was made and seconded to approve the minutes of the February 15, 2022, meeting as distributed. Motion passed.

Unfinished Business:

Tonya Brumley discussed previous years' WCUCC donation for the Cherry Festival Parade candy. After a discussion with members, a motion was made and seconded to partner with NW Natural and reimburse Tonya Brumley \$294.00 for the parade candy. Motion passed.

Contractors Night: Tonya indicated that when a date is set, NW Natural can partner with 811 to help share in the costs for the event. Prior events are usually held in the spring, have also been held in the fall, and one has been held over breakfast. Springtime turns out the most attendees. It was suggested that we move forward with a contractor's night, to be held in the Spring of 2023. Tonya Brumley and Jennifer Lindsey will work together and come up with an agenda. It was suggested to hold the event at The Bargeway and offer dinner and a drink voucher to attendees. As new information is available, it will be shared with the WCUCC members. Dale McCabe suggested in the interim holding a "meet and greet" event to introduce new staffing as there have been many changes across the board.
