

WASCO COUNTY UTILITIES COORDINATING COUNCIL

MEETING MINUTES January 18, 2023 8:44 a.m.

Jacob Gilbertson called the meeting to order at 8:44 a.m. from the boardroom at Wasco Electric Cooperative.

Minutes:

A motion was made and seconded to approve the minutes of the December 20th, 2022, meeting as distributed. Motion passed.

Report of Officers:

President, Jacob Gilbertson – None reported.

With the new officers and new members present, Jacob Gilbertson held a round table of individual introductions for members present.

Unfinished Business:

Jacob Gilbertson reopened the discussion for the proposed WCUCC Bylaw changes. The Third Revision of the Bylaws was presented. No changes were recommended. The council will present at the February meeting and look to approve the Bylaws as presented.

New Business:

Jennifer Lindsey reviewed the OUCC annual funding procedures and requested budget events planned for 2023. A discussion was held by council members regarding the sponsorship of an archery target at the Celilo Bowman's Club to create awareness of 811 Call Before you Dig. After a lengthy discussion, a motion was made and seconded to approve an annual membership for 2023 in the amount of \$100.00 with Celilo Bowman's Club, following an amended motion to approve a scholarship for the annual membership for 2023 in the amount of \$100.00 to Celilo Bowman's Club for 2023, as memberships generally cover an individual or family. Motion passed. Dale McCabe will complete the membership application and submit it to Arthur Smith for payment. Jennifer Lindsey will send Dale the artwork files for the 811 advertisement.

Other discussed opportunities for budgeted events in 2023 were Cherry Festival sponsorship, the continued sponsorship of the City of The Dalles clean-up contribution towards the food that will be served, as the WCUCC has done in the past and donation to the Cherry Festival parade candy. Previously approved expenses included the, The Dalles Baseball Student-Athletes 10' x 6' field spot advertisement. Jennifer will report these budgeted events to the OUCC.

Jennifer reported that the use of 811 Call Before you Dig on council members social media platforms is acceptable with a few exceptions. Council members do have access to 811 messages and artwork, in terms of copywriting, members cannot switch out colors (pms color match), and bilingual materials are available free at https://oregon811.mydormer.com/shop or https://digsafelyoregon.com. Members can download the standard manual and excavator checklist in Spanish.

Jennifer will forward the artwork files she received from Kitty O'Keefe with OUNC to council members.

Damage Report:

Jacob Gilbertson with NW Natural reported that they experienced 1 damage issue with a contractor installing new water service, white brackets were painted 10' outside of the property. The locates were done on the entire property with locate area painted in white. They ended up just outside of the property to tie into pole and hit neighbors' service. Locate did not confirm service inside the brackets. Had the locator go by the area that was indicated, he would have caused major damage. By locating outside of the area, damage was prevented.

Jerry Anderson with City of The Dalles reported that they experienced 3 main breaks within the last month. Inquired to see if NW Natural had any emergency contact information for locates; Jacob stated that Aaron Westfall is a first responder. Jerry concluded that 2 out of the 3 locaters never came out and he had to initiate a second emergency locate request. Jacob stated that he will get Jerry additional contacts.
